The enclosed information is released by the National Practitioner Data Bank (NPDB) for restricted use under the provisions of Title IV of Public Law 99-660, the Health Care Quality Improvement Act of 1986, as amended; Section 1921 of the Social Security Act; and Section 1128E of the Social Security Act.

Title IV established the NPDB as an information clearinghouse to collect and release certain information related to malpractice payment history and professional competence or conduct of physicians, dentists, and other licensed health care practitioners.

Section 1921 of the Social Security Act expanded the scope of the NPDB. Section 1921 was enacted to protect program beneficiaries from unfit health care practitioners, and to improve the anti-fraud provisions of federal and state health care programs. Section 1921 authorizes the NPDB to collect certain adverse actions taken by state licensing and certification authorities, peer review organizations, and private accreditation organizations, as well as final adverse actions taken by state law or fraud enforcement agencies (including, but not limited to, state law enforcement agencies, state Medicaid Fraud Control Units, and state agencies administering or supervising the administration of a state health care program), against health care practitioners, health care entities, providers and suppliers.

Section 1128E of the Social Security Act was added by Section 221(a) of Public Law 104-191, the Health Insurance Portability and Accountability Act of 1996. The statute established a national data collection program (formerly known as the Healthcare Integrity and Protection Data Bank) to combat fraud and abuse in health care delivery and to improve the quality of patient care. Section 1128E information is now collected and disclosed by the NPDB as a result of amendments made by Section 6403 of the Affordable Care Act of 2010, Public Law 111-148. Section 1128E information includes certain final adverse actions taken by federal agencies and health plans against health care practitioners, providers, and suppliers.

Regulations governing the NPDB are codified at 45 CFR part 60. Responsibility for operating the NPDB resides with the Secretary of the U.S. Department of Health and Human Services (HHS), and HRSA, Division of Practitioner Data Banks.

Reports from the NPDB contain limited summary information and should be used in conjunction with information from other sources in granting privileges, or in making employment, affiliation, contracting or licensure decisions. NPDB responses may contain more than one report on a particular incident, if two or more actions were taken as a result of a single incident (e.g., an exclusion from a federal or state health care program and an adverse licensure action). The NPDB is a flagging system, and a report may be included for a variety of reasons that do not necessarily reflect adversely on the professional competence or conduct of the subject named in the report.

All information received from the NPDB is considered confidential and must be used solely for the purpose for which it was disclosed. Further, ANY PERSON WHO VIOLATES THE CONFIDENTIALITY PROVISIONS AS SPECIFIED IN TITLE IV OF PUBLIC LAW 99-660, AS AMENDED, IS SUBJECT TO A CIVIL MONEY PENALTY OF UP TO \$11,000 FOR EACH VIOLATION. ON SEPTEMBER 21, 2015, THE IDAHO BOARD OF MEDICINE ISSUED AN AMENDED FINAL ORDER PROVIDING ONLY A PUBLIC REPRIMAND AND ORDER TO COMPLY WITH IDAHO TELEHEALTH ACCESS ACT AND RELATED RULES. THIS AMENDED FINAL ORDER RETROACTIVELY CHANGED THE INITIAL REPORT TO SHOW A REPRIMAND RATHER THAN A RESTRICTION ON THE LICENSEE.

We write on behalf of Dr. Ann DeJong regarding various reports issued by the Idaho Board of Medicine (IBOM) which were not filed in accordance with Data Bank regulations and which do not accurately reflect the written records of the IBOM. The original report, DCN 5500000086880913 (the 913 report), which is the specific subject of this dispute, was filed January 2, 2014 as a State Licensure Action. A second report, DCN 5500000100335613 (the 613 report), was filed on September 21, 2015 as a Revision to State Licensure Action and related to the prior 913 report. A third report, DCN 5500000100447410 (the 410 report) was filed by IBOM on October 7, 2015 as a Correction of Revision to State Licensure Action; as a result of that filing, the second 613 report appears to have been expunged from Dr. DeJong's NPDB records. The original 913 report was filed as a result of disciplinary action taken by IBOM and indicated, erroneously, there was a restriction on Dr. DeJong's license. That classification as a restriction (an 1147 code) was based on language contained in the IBOM's Order dated January 2, 2014 which read in part: "Respondent shall not provide any type of medical/health care via telephone/email

medical consultations (telemedicine) to Idaho citizens." (Exh. A - 1/2/14 Order, attached to Points of Dispute). Based on acknowledgement by IBOM's counsel that a restriction was not intended (see exh. B - letter from Ms. [ND]), Dr. DeJong filed a Petition to Modify the Board Order and the NPDB report. The IBOM issued an Amended Final Order which made clear, among other things: ". . . the Final Order entered January 2, 2014, is modified as of its effective date to reflect its original intention to require that Dr. DeJong comply with current Idaho legal standards applicable to telemedicine rather than impose licensure or practice standards greater than those applicable to licensed physicians in the State of Idaho." (Exh. C - Amended Final Order, attached to Points of Dispute.) The Order required that the IBOM appropriate amend the NPDB report. (Id.) Prior to the IBOM filing the 613 report in September, counsel for the Dr. DeJong and the IBOM communicated extensively regarding the appropriate form of the report. (See exh. D - email correspondence between Attorneys [Name Deleted (ND)] and [ND], attached as evidence of attempted resolution). IBOM's counsel insisted for reasons that remain unclear that the appropriate form of the report would be a "revision" rather than a "correction." Counsel for IBOM refused to even seek guidance from the Data Bank on the correct form of the report. (See exh. D.) The IBOM filed the 613 report as a "revision" of the earlier 913 report. This distinction proved more than just academic to Dr. DeJong as potential employers expressed concern to her over the period of time her license was "restricted." Dr. DeJong, through counsel, reached out to NPDB for assistance. After Dr. DeJong's counsel initially contacted NPDB, the IBOM without notice to Dr. DeJong's counsel, file a third report, the 410 report. Again, it appears that that report was not filed as a correction of the 913 report, but rather a "Correction of Revision." Because this corrected the revision, but not the original report, the result is that the second report (the 613 report) has been expunged, but the original (the 913 report) remains. It now appears to anyone accessing NPDB's records that the IBOM has issued two actions against Dr. DeJong, including an initial restriction followed by a subsequent censure. The original 913 report stating that IBOM indefinitely limited or restricted Dr. DeJong's license (an 1147 code) on January 2, 2014 remains and this should be expunged. The third 410 report should be expunged and replaced by a report of a State Licensure Action against Dr. DeJong for a reprimand (1140 code), based on a public reprimand issued by the IBOM.
