This letter regards a request from Anne De Jong, MD, that the Secretary of the US Department of Health and Human Services ("the Secretary") review the above-referenced State Licensure Action Report ("the Report") submitted to the National Practitioner Data Bank ("the NPDB") by the Medical Board of California ("the California Board") on **July 30**, **2015**.

According to the record, the California Board reported Dr. De Jong for "Reprimand or Censure (1140)." The **Basis for Action** indicates "License Revocation, Suspension or Other Disciplinary Action Taken by a Federal, State or Local Licensing Authority (39)." The **Description of Subject's Act(s) or Omission(s) or Other Reasons for Action(s) Taken and Description of Action(s) Taken by Reporting Entity field in Section C of the Report states: "Public Reprimand."**

- Dr. De Jong has disputed the reportability to the NPDB of the State Licensure Action taken by the California Board and claims that:
- 1. There is no record of discipline against her by the State of Idaho and she was informed that "it is as if no complaint had ever been brought."
- 2. During her efforts to resolve matters with the State of Idaho, the State of California instituted a reciprocal disciplinary action, "Discipline, Restriction, or Limitation Imposed by Another State."
- 3. California refused to delay resolution of the California action until after matters had been resolved with Idaho.

On April 23, 2019, a search by this office of the California Board's online public records indicated a Medical License # A118790 for Ann De Jong, issued October 21, 2011 and expiring September 30, 2019. The search also indicated a disciplinary action (public reprimand for minor violation of the law), subsequent to the California Board Order # 8002014002486, effective July 31, 2015.

In a letter dated May 23, 2019, this office requested additional documentation from the California Board to support the explanation and information in the Report, to include the sequence of relevant events that led the California Board to issue the Order and file the State Licensure Action Report with the NPDB.

That May 23, 2019, documentation request is still valid, and your response is due to us on June 27, 2019.

However, since that letter was sent, this office has received information (enclosed) from the Idaho State Board of Medicine ("the Idaho Board"), indicating that subsequent to litigation between Dr. De Jong and the Idaho Board, a Settlement Agreement dated March 27, 2018, was reached in which it was agreed that the Idaho Board would void its Amended Final Order and the related disciplinary action from Dr. De Jong's record and would void the Corrected Report (Idaho) in the NPDB and report the matter as "reversed". In a letter sent to this office by the Idaho Board (enclosed), "the original Order

and subsequent Amended Order were entered in error." **Dr. De Jong's record is to be treated as "clear, and the disciplinary action is treated as having never occurred."**

The Basis for Action for the California Board's Report to the NPDB is based on reciprocity with the Idaho Board. Given that the Idaho Board has reversed its disciplinary action and voided its Order and Dr. De Jong's Report, this Basis for Action by California no longer exists, and the California Report is based on outdated and incorrect information. As Dr. De Jong's attorney notes in his letter (enclosed), "...the California NPDB Report gives the false and incorrect impression that there is Idaho discipline against Dr. De Jong."

While the Secretary cannot substitute his judgment for that of the California Board, we would like to know your position on the matter of the validity of Dr. De Jong's California Report and ask that you please keep us informed.

It should be noted that this letter does not constitute a decision concerning Dr. De Jong's request for Dispute Resolution of the Report.

While I cannot have *ex parte* discussions concerning the substance or merits of Data Bank Reports or Dispute Resolution cases, I can answer questions about procedure or form. If you have questions, please contact me at 301.443.2300.

You have initiated a request for Dispute Resolution.

*** IMPORTANT - PLEASE READ ***

The law strictly limits the Data Bank's jurisdiction in these cases. Please note that the Dispute Resolution process is not an avenue to protest the underlying merits of a case that resulted in the report itself. Such request will be deemed outside the scope of review and will be so noted on the report. The Data Bank cannot determine whether a reporting entity's decision to take an action concerning licensure privileges, exclusion, etc., was correct or fair.

The Data Bank can only determine if the report:
